- Committee meetings January 20th and February 24th
- 22 written testimonies submitted for 9 bills
- Legislative focus included:
 - Tobacco and vaping
 - Expanding scope of practice for PAs and APRNs in order to expand access to care
 - Protection of reproductive health access and rights in the state
 - DOE to stock bronchodilators for trained persons to administer at school for emergency use during an asthma attack
 - Extend the sunset date for the early lung cancer screening task force and extend the date for the task force to submit reports to the legislature

Enrolled to Governor

- SB109 Relating to Gender-Neutral terminology in adoption and divorce matters
- SB944 Extends and modifies the task force established to recommend amendments to update existing parentage laws that reflect outdated, cisheteronormative concepts of families, parenthood, and parental rights to December 31, 2024.

Did not pass

- B100 Relating to Gender-Neutral terminology in adoption and divorce matters
- SB891 Relating to Menstrual Products- Requires the Department of Accounting and General Services to provide menstrual products at no cost in specified restrooms of public buildings maintained by that department
- HB1393 Establishes certain parental rights. Prohibits the State and counties from enacting any rules, regulations, or laws that infringe upon these parental rights.
